I. Financial report -

- a. Treasurer's Report - Current balance of bank assets

II. President report

- a. Board structure proposal - suggestion to restructure the Board.
 - i. Benefits: 1) there is no end or process for replacement or chance for someone else to take over, 2) voting members are highly active Board members - too many votes currently. Suggesting 7 voting members: President, VP Rec, VP Travel, Secretary, Treasurer, Rec Registrar, Travel Girls Registrar, Travel Boys Registrar.
 - ii. All of these positions are two year terms. If no one else is interested at that time, the current person can maintain their position if they so choose. Voting at the end of spring season. Suggestion to email the entire club to ask for vote.
 - iii. Suggestion to have a tournament person.
 - iv. Consider discussing which tournaments each travel team is registering for so we can sit together.

 - i. Done as of next spring unless they find fields. Will likely have more families switching to our club next year.

III. Intramural report

- a. Registration numbers - rec - 46 , little kickers - 19 as of 6/14
- b. Fundraisers - a few trucks booked for super soccer. Will get with Jess to get additional food trucks and restaurant nights. Would be ideal to have 1 every week or every other week sept - end of october

- c. Keep posting and sharing about fall registration - working with Steve K to remind about fall registration.
- d. Rec general meeting date - 1 pm on August 16th at New Oxford Middle School.
- e. Can start reaching out to food vendors to come to fields during practice nights
- f. Area league meeting recap - met with several clubs, may have U12 and U14 play other clubs if we don't have enough teams in-house. August 23rd prelim schedule, final schedule August 30th. These clubs are playing by EPYSA rules (parents and players must sit on opposite sides of the fields). These clubs also want to revisit all boys and all girls teams. Bermudian Springs struggled the first year but once word got out, more girls registered because they prefer to not play against boys. If we have enough numbers, allow players and parents to choose if they want to be on all-girl, all-boy, or co-ed team.

Include in coach meeting.
